

# Privacy policy Zantey version 2020.01.02

Zantey ApS is committed to protecting the Personal Data of our customers, suppliers and partners. This policy describes our data protection practices and how we use and collect Personal Data. Our processing of your Personal Data is needed for us to deliver service and products to you or placing orders or services with you company. We may also process your Personal Data in order to comply with our legal obligations as explained below or due to our legitimate interests.

### 1. PERSONAL DATA WE COLLECT

We will collect Personal Data from you in the following circumstances:

When you place an Order; we will collect your first and last name, E-mail address, postal address, phone number, payment information, such as your company's Account information, communications and correspondence sent to and from you, information about Order histories and/or Artwork histories.

When you contact us regarding products or orders, or for Customer Support or other customer service purposes; we may collect your name, e-mail address, phone number, and any communications from you to us.

When you ask us to create or design products: We may collect any images, text, logos or other Content that you submit, including information related to or included within such Content.

### 2. PURPOSE AND USE OF PERSONAL DATA:

We use your Personal Data for the following purposes:

- To provide you with our Products and the Services and to evaluate, modify and enhance the Products and Services
- To process your payment, facilitate billing and issue invoices, as applicable
- To communicate with you and to respond to your requests
- To provide you with customer service and support
- For legal obligation purposes, i.e. post market surveillance and vigilance according to the MDR
- To help keep our Website safe and secure and to improve the Website.

We use Automatic Information to administer the Website and track user activities on the Website. We will create anonymous data records from Personal Data by excluding information (such as your name) that makes the data personally identifiable to you. We use such Anonymous Data records to analyze request and usage patterns so that we may enhance the Content of the Services and improve Website navigation.

# 3. HOW WE SHARE YOUR PERSONAL DATA

We disclose your Personal Data as described below. No Personal Data provided by you or that we may obtain automatically by your use of the Website, is not and will not be sold, rented, or shared by us with any third party without your prior consent.

### **Transfer and Storage of Personal Data**

Your Personal Data will be transmitted, uploaded, transferred, stored, or backed up at Zantey's GDPR compliant cloud provider DropBox International Unlimited Company.

### Members of our group

We may share your Personal Data with any member of our group, which means our subsidiaries and our parent company in Order to perform our Services and deliver products to you.

# **Third Party Service Providers**

We will share your Personal Data with third party companies and individuals who perform Services on our behalf to help us provide the Services and deliver products to you. This may mean a transfer of your personal data out of EU. Other examples of Services that may be provided by Third Party Service Providers may include, but are not limited to: processing credit card payments with our payment provider in EU, providing customer service by our suppliers in EU; USA and China, and maintaining our customer lists by our service providers in EU. Third Party Service Providers acting on our behalf are only provided with such Personal Data reasonably required to provide the particular service for which they are retained. Our Third-Party Service Providers are obligated to keep all of your Personal Data confidential and to collect, use and disclose your Personal Data only to the extent necessary to provide the Services on our behalf. They are fully compliant to the EU GDPR regulation and have signed a Data Processing Agreement with Zantey.

# **Business Transfers**

We may share some or all of your Personal Data in connection with or during negotiation of any merger, financing, acquisition or dissolution, transaction or proceeding involving sale, transfer, divestiture, or disclosure of all or a portion of our business or assets. In the event of an insolvency, bankruptcy, or receivership, Personal Data may also be transferred as a business asset. If another company acquires our company, business, or assets, that company will possess the Personal Data that we have collected and will assume the rights and obligations regarding your Personal Data as described in this Privacy Policy. The company may need your consent to continue handling your data.

#### Compliance with Law, Court Order, and Other Disclosures

You hereby acknowledge and agree that Zantey may, in its sole discretion, release Personal Data when we believe such release is appropriate: (a) to comply with an applicable law, statute, regulation, Court Order, or administrative proceeding; (b) in connection with any legal investigation; (c) to investigate or assist in preventing any violation or potential violation of this Privacy Policy or our Cookie Policy; or (d) to protect the rights, property, or safety of Zantey, our users, or others. This may include exchanging information with other companies and organizations for fraud protection and credit risk reduction.

#### **Third Party Sites**

scientific organizations' Websites or third-party Websites may otherwise be associated with the Website. We employ security safeguards to protect your Personal Data against loss or theft, as well as against unauthorized access, disclosure, copying, use, or modification. We do not transmit highly confidential information over the Internet.

### 5. IDENTIFYING DATA CONTROLLERS AND PROCESSORS

Zantey is also a Data Controller of your personal data. Our third-party suppliers, are Data Processors. This means they are processing the data on yours and Zantey's behalf.
